The official canvass of ballots for the March 7, 2017 City of Clovis General Municipal Election was conducted March 7 – 16, 2017 by the Fresno County Registrar of Voters. The canvass has been completed in accordance with the California Elections Code.

**RESOLUTION NO. 17-**

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVIS DECLARING  
RESULTS OF THE ELECTION HELD ON MARCH 7, 2017**

WHEREAS, a general municipal election was held and conducted in the City of Clovis, on Tuesday, March 7, 2017, as required and prescribed by law, for the purpose of electing two (2) members of the City Council for the full term of four years (March 2017 – March 2021) and a special election for one (1) member for term of two years (March 2017 – March 2019) to complete the regular term of a vacated position.; and,

WHEREAS, it appears to the satisfaction of the City Council of the City of Clovis that holding said election was duly and legally given for the time and in the manner prescribed by law, that the voting precincts were properly established, that the election officers were appointed and election supplies furnished, and that in all respects, said election was held and conducted, and the votes cast thereat received and canvassed, and the returns thereof made and declared in the time, form, and manner as required by the General Government Code and Elections Code of the State of California; and

WHEREAS, the Council of the City of Clovis met in the Council Chamber of Clovis Civic Center, 1033 Fifth Street, in the City of Clovis on Monday, March 27, 2017, at the hour of 6:00 P.M., to examine the Statement of Votes cast at said election as certified by the Fresno County Clerk / Registrar of Voters, declare the results of said election and install the newly elected officers pursuant to the provisions of the Elections Code of the State of California. Said County Clerk / Registrar of Voters having canvassed said returns in the form and manner required by law, and having certified the results of the canvass of the general municipal election returns to the City Council, and said results are received, attached, and made a part hereof as Exhibit 'A', the Council finds that the whole number of votes cast, results, and all other matters required by law, to be as hereinafter stated;

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Clovis, as follows:

1. That said general municipal election was held and conducted in the City of Clovis on Tuesday, the 7<sup>th</sup> day of March 2017, in the time, form and manner required by law.

2. That there were a total of 43 voting precincts, consisting of consolidations of the regular election precincts of the City of Clovis, established for the holding of state, county, and municipal elections.

3. That the total number of ballots cast in said City at said election is 9,395, the names of the persons voted for and the whole number of votes received is as shown in Exhibit 'A', and the results as shown in Exhibit 'A' are hereby approved.

4. That at said general municipal election, three persons, Lynne Ashbeck and Vong Mouanoutoua were elected Council Members for a full four (4) year term through March 2021 and Drew Bessinger was elected to a two (2) year term through March 2019.

5. A Certificate of Election shall be executed and delivered to each person so elected. The City Clerk shall administer, to each person so elected Council Member, the oath of office prescribed in the State Constitution, and have each of them subscribe thereto, whereupon they shall be inducted into the respective offices to which they have been elected.


