There is a need to consider that information and take immediate action before the next Council meeting. Therefore, staff requested Council to add an additional closed session agenda. It will take a motion and a 4/5 vote of the Council to add the item. The item will be heard at this location, not the scheduled location for the other closed session item. There being no public comment, Mayor Whalen closed the public portion. Discussion by the Council. Motion by Councilmember Flores, seconded by Councilmember Ashbeck, for the Council to add an additional closed session agenda item to this meeting regarding the City's TCP water contamination case. Motion carried by unanimous vote.

Mayor Whalen presented a report regarding a Planning Commission Appointment. Planning Commissioner Mike Pawlowski's term of office expires in May of 2017. Mr. Pawlowski does not want to be reappointed for another 4-year term. Mayor Bob Whalen and Planning & Development Services Director Dwight Kroll conducted interviews with citizens who made application and expressed interest in serving on the Planning Commission. Mayor Whalen recommends the appointment of William Terrence to the Planning Commission to replace Mike Pawlowski. Mr. Terrence's appointment would become effective on May 1 and his proposed term of office would end in May 2021. Mr. Terrence spoke briefly and introduced himself and his family. Council to appoint William Terrence whose term would become effective May 1, 2017 and end in May of 2021. Motion carried by unanimous vote.

6:21 ITEM 1A - APPROVED - RES. 17-34, CUP2016-04, APPROVING A CONDITIONAL USE PERMIT FOR A PROPOSED 18-BED, SINGLE-STORY EXTENDED CARE FACILITY WITH ASSOCIATED PARKING ON APPROXIMATELY ONE ACRE OF LAND LOCATED AT 250 VILLA AVENUE. PAGOSYAN FAMILY TRUST, OWNER; VANIK & ARSEN LLC, APPLICANT; JOSE LUIS VARGAS, REPRESENTATIVE.

Associate Planner Orlando Ramirez presented a report on a request to approve a conditional use permit for a proposed 18-bed, single-story extended care facility with associated parking on approximately one acre of land located at 250 Villa Avenue. The applicant is requesting approval of a conditional use permit to allow a 12,700 square foot extended care facility at the Project site. The Project includes an 18-bed facility for short and long-term care of adult patients. Approval of this conditional use permit will allow the developer to move forward with the Site Plan Review process and development of the site. Some issues of discussion included in this report deal with comments and direction from the City Council at the December 12, 2016, public hearing specific to the number of patients proposed at the facility, compatibility with the surrounding area and neighborhood outreach. The applicant's proposal was presented to the City Council for consideration. Area residents expressed concern that the facility could be considered a commercial facility within a residential setting and could affect traffic to the area. The Council had concerns with the proposed building size, noting that it should be reduced in size in order to fit in character with the surrounding neighborhood. Additionally, the Council felt that the number of patients requested (18), should be reduced in order to limit activity to the area. Subsequently, the Council stated that they did not feel the applicant had conducted comprehensive outreach to area residents on the specific nature of the Project. The Council did not take action on the use permit, continuing the item until the applicant had an opportunity to conduct a broader outreach with area

property owners. Subsequent to the December 12, 2016, City Council meeting, the applicant met with staff on several occasions in working out a solution to address the concerns raised.

Dirk Poeschel, representing the applicant, spoke in support of the project and addressed questions of City Council. Discussion by the Council. Motion by Councilmember Ashbeck, seconded by Councilmember Mouanoutoua, for the Council to approve a conditional use permit for a proposed 18-bed, single-story extended care facility with associated parking on approximately one acre of land located at 250 Villa Avenue adding Condition 13a. The developer shall comply with the operational statement attached as Exhibit 1. Motion carried by unanimous vote.

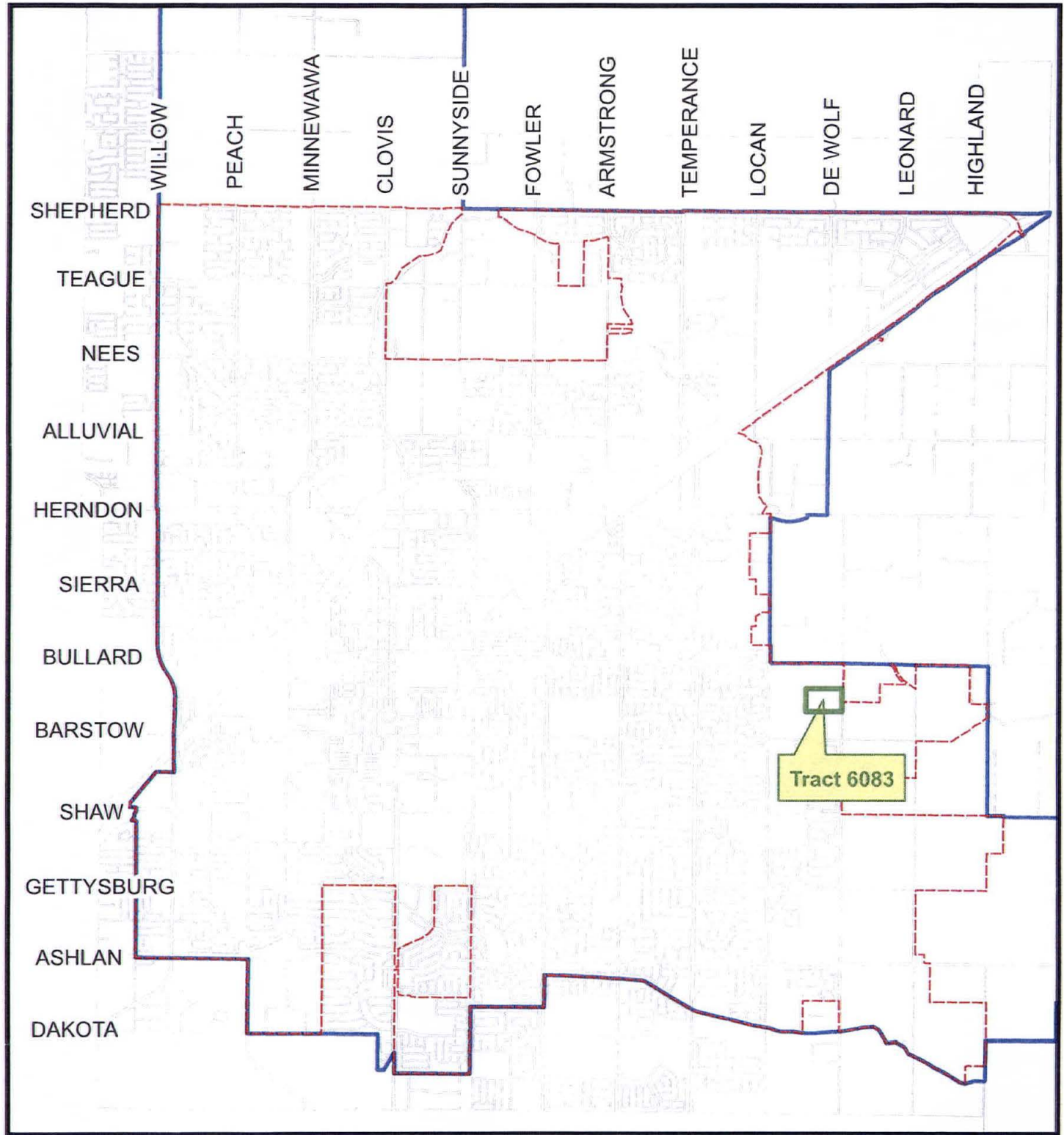

EXECUTIVE SUMMARY

The owner, Two Creeks South LP, Wilson Homes, has requested final acceptance of the public improvements constructed or installed in conjunction with this tract. The public improvements include all those shown on the subdivision improvement plans approved by the City Engineer.

The owner has requested a deferment of sidewalk and street tree improvements to the building permits of adjacent lots. Construction of sidewalk improvements will require an encroachment permit for each lot. The street trees will be installed and sidewalk improvements will be completed according to the approved plans and ADA specifications prior to finaling the lot.

With the exception of the sidewalk and street trees, the construction or installation of the public improvements is complete. The owner has requested final acceptance. Staff is recommending approval of their request.

FISCAL IMPACT

The costs for periodic routine maintenance, as well as repairs needed as the improvements deteriorate with age and usage, will be incorporated into the annual maintenance budget of the Public Utilities Department as these costs are identified.

REASON FOR RECOMMENDATION

The Subdivision Map Act requires that once construction of the required improvements has been completed in compliance with all codes, plans and specifications, and all other required documents have been completed and submitted, final acceptance is required and the appropriate sureties are released.

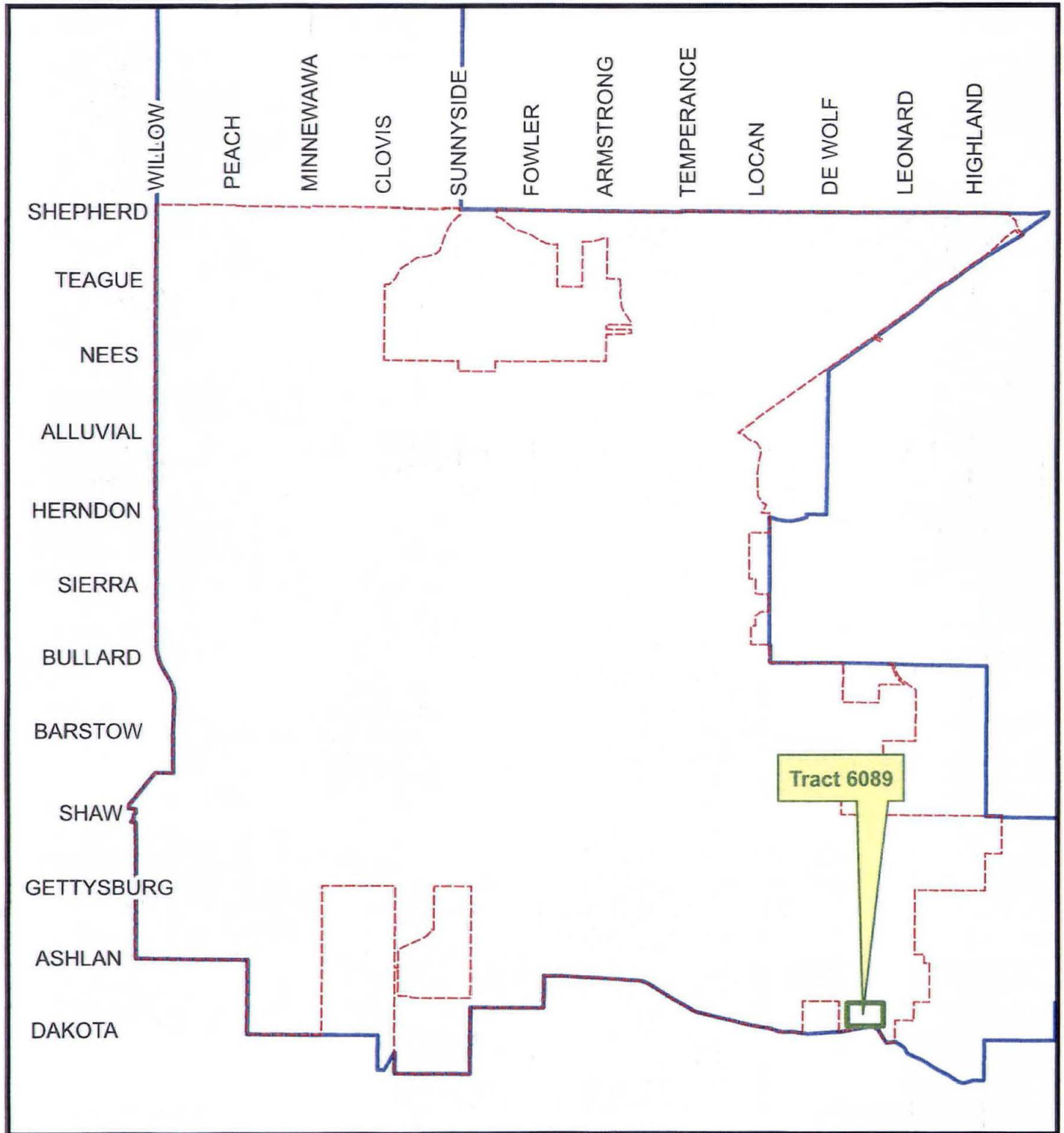

1. For the City Council to award a contract for CIP 17-01 Rubberized Cape Seal 2017 to VSS International, Inc. in the amount of \$1,121,375.00 and;
2. For the City Council to authorize the City Manager to execute the contract on behalf of the City.

EXECUTIVE SUMMARY

The construction involves applying approximately 140,000 square yards± of rubberized cape seals at various local streets. This project also involves crack sealing and installation of 260,000 square yards± of Type II slurry seals at various additional local streets. The work shall include, but not be limited to, removal of all existing traffic striping, markings and markers, furnishing and installation/application of rubberized asphalt chip seal, Type II slurry seal, traffic control, street sweeping, cleanup, traffic striping and all other items or details required.

Staff has evaluated the project site for all design aspects within the scope of the project for compliance with the Americans with Disabilities Act (ADA) accessibility standards as of April 10, 2017. The project was constructed to meet ADA standards.

BACKGROUND

All bids were examined and the bidders' submittals were found to be in order. Staff has validated the lowest responsive bidder contractor's license status; the contractor is in good standing with no record of complaints but one violation recorded in the last three years. A record search for complaints or violations was performed through Cal OSHA and there were two violations found, one in 2016 and one in 2013.

FISCAL IMPACT

This project was approved in the 2016-2017 fiscal year budget. The project is solely supported by the City Community Investment Program at the request by the Public Utilities Department.


REASON FOR RECOMMENDATION


VSS International, Inc. is the lowest responsible bidder. There are sufficient funds available for the anticipated costs of this project.

ACTIONS FOLLOWING APPROVAL

1. The contract will be prepared and executed, subject to the Contractor providing performance security that is satisfactory to the City.
2. Construction will begin approximately two (2) weeks after contract execution and be completed in sixty (60) working days thereafter.

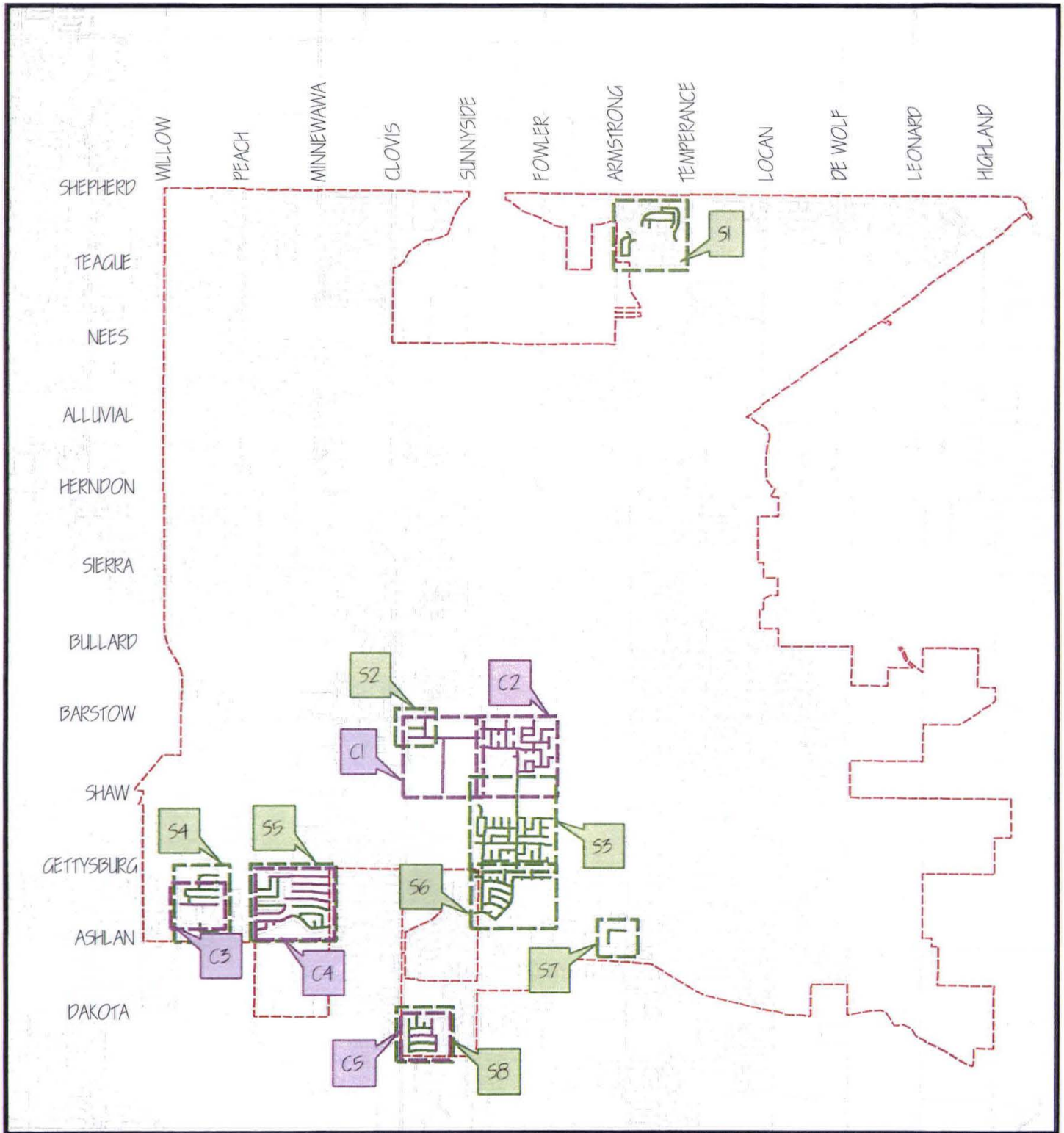

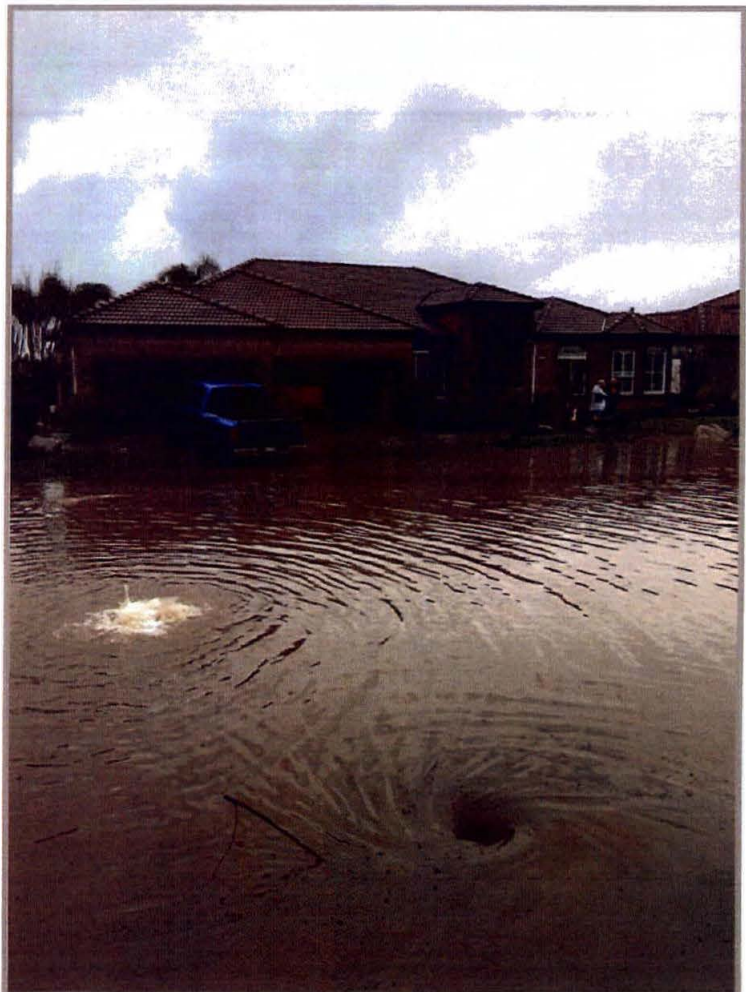

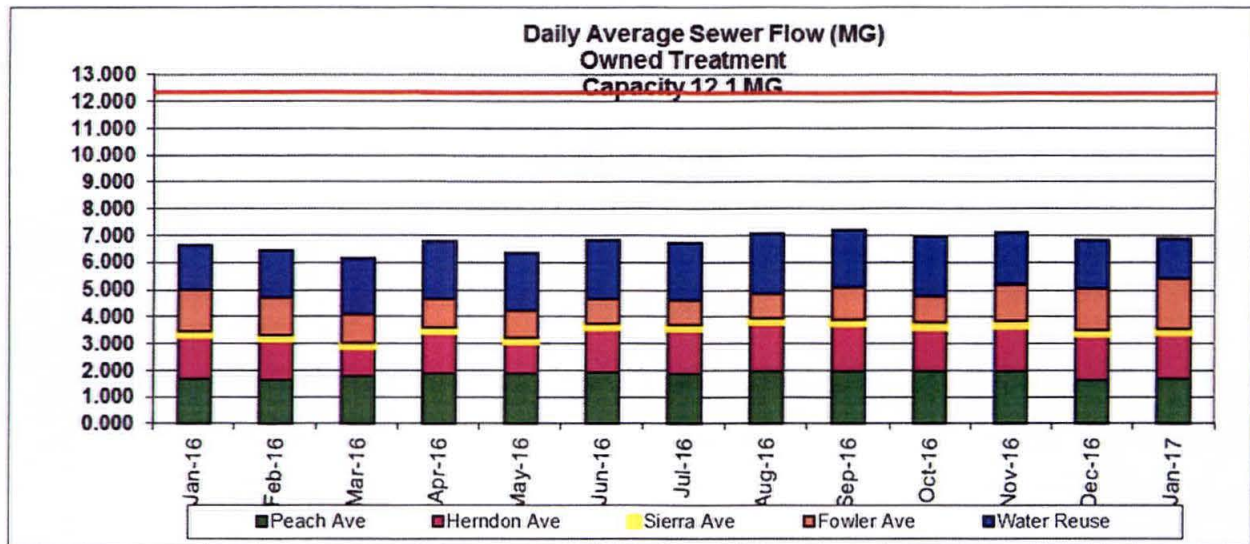
Thursday, January 12th the City experienced a significant rain event. This storm followed three previous days of measureable rain. By mid-day many areas of the City were impacted by intense rain during a short duration of time. Localized street flooding occurred in several areas where the intensity was too great for storm drains to keep up. Some flood control district basins filled to capacity. Public Utilities Department staff worked with other City departments including Police and Fire and the Fresno Metropolitan Flood Control District fielding flooding complaint calls, performing temporary street closures, checking storm drains, replacing dislodged storm drain covers, and providing sandbags to residents.

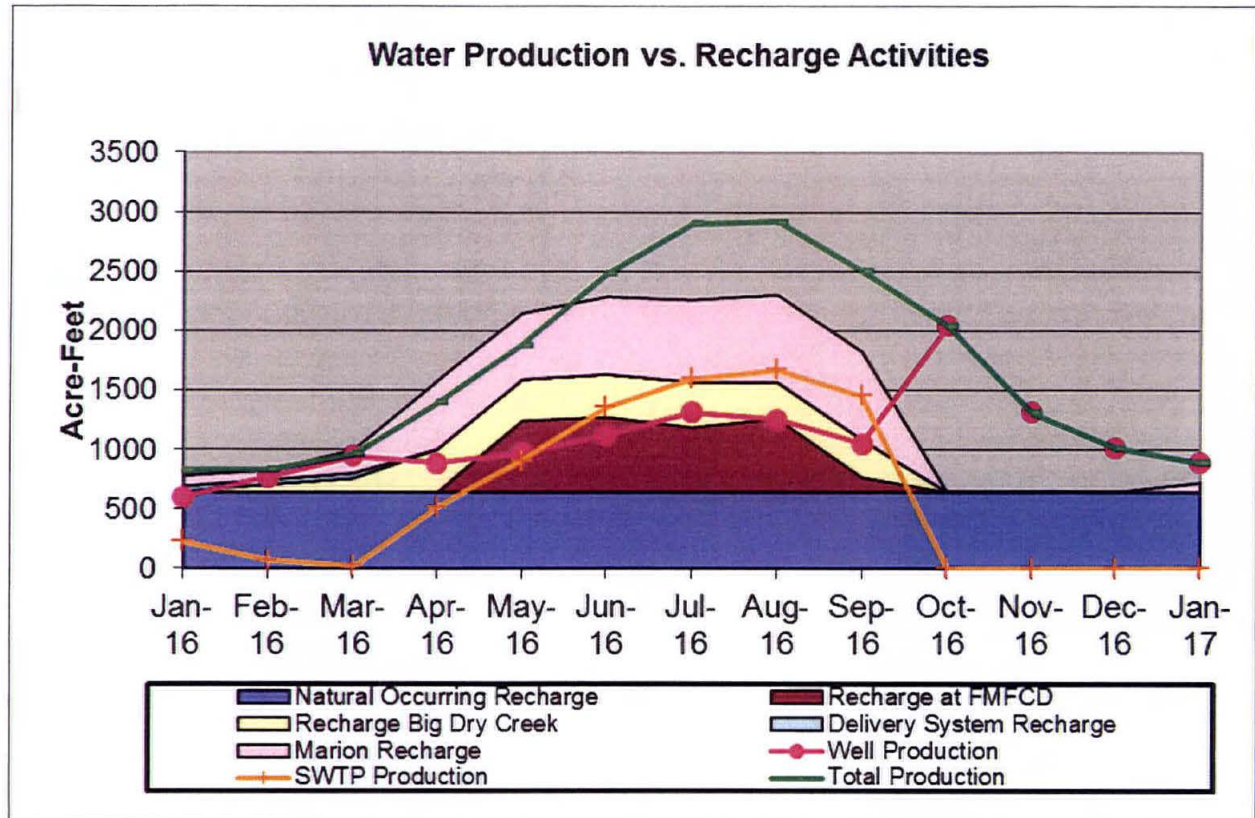

NOT JUST POTHoles...SINKHOLES TOO!

During this incredibly wet winter, the PUD Street Paving Crew has been repairing hundreds of potholes of various shapes and sizes. However, another pavement problem has also been occurring in greater numbers during this rainy season... sinkholes! Just like potholes, water intrusion under the pavement degrades the foundation of the asphalt, but the problem can occur in extremely large areas too. Sinkholes may also be caused by water intrusion into poorly compacted trenches which can also cause damage to underground pipes. When sinkholes occur, the crew must mobilize quickly because they know that a large sinkhole can be extremely hazardous to the travelling public. Instead of just filling in the pothole and moving on to the next, the sink holes must be saw cut, excavated (to find and repair the reason it occurred), backfilled, compacted, and repaved. A sinkhole of this size (pictured) often requires the manpower and talents of the entire crew to swiftly complete the work so they can get back to repairing potholes. The crew is well aware that new potholes are developing every hour they are not on pothole patrol.
