Finance Director Jay Schengel presented a report on actions related to annexation of territory (Annexation #56 - T6181 – Northeast Corner of Shaw and Leonard) to the City of Clovis Community Facilities District (CFD) No. 2004-1 (Police and Fire Services). Since the condition to establish a CFD was imposed on the developments being processed by the City, developments proceeding after March 8, 2004 must petition to be annexed to the existing CFD. This action is required to begin the process of annexation provided by the conditions of approval of the development entitlements. Jay Schengel provided an overview of Annexation #56. There being no public comment, Mayor Whalen closed the public portion. Discussion by the Council.

Motion by Councilmember Ashbeck, seconded by Councilmember Flores, for the Council to approve **Resolution 19-02**, for the Council to approve a Resolution annexing territory (Annexation #56 - T6181 - Northeast Corner of Shaw and Leonard) to the city of Clovis Community Facilities District (CFD) No. 2004-1 (Police and Fire Services) and calling a special landowner election to annex territory (Annexation #56) to City of Clovis Community Facilities District No. 2004-1 (Police and Fire Services). Motion carried by unanimous vote.

City Clerk John Holt reported out that he was in receipt of one ballot representing 40 votes all in favor and noted unanimous passage of the ballot measure. There being no comment, Mayor Whalen closed the public portion. Discussion by the Council.

14. APPROVED – **RES. 19-04,** APPROVING THE EXCEPTION TO THE 180-DAY WAIT PERIOD (GOVERNMENT CODE SECTIONS 7522.56 & 21224) PERTAINING TO THE HIRING OF LARRY LOUIE AS EXTRA HELP FOR CRITICAL PUBLIC FACILITY PROJECTS – **6:50 p.m.**

General Services Director Shonna Halterman presented a report on a request to approve an exception to the 180-Day Wait Period (Government Code Sections 7522.56 & 21224) pertaining to the hiring of Larry Louie as extra help for critical public facility projects. The General Services Department requests authority to utilize the exception provided in Government Code section 21224 to hire a retired CalPERS employee for the limited duration, not to exceed one year, to complete and/or train a new employee related to several critical ongoing infrastructure projects that are highly technical and specialized in nature and can have a detrimental effect on City facilities as well as the staff and people of Clovis if delayed or completed improperly. There being no public comment, Mayor Whalen closed the public portion. Discussion by the Council.

Motion by Councilmember Ashbeck, seconded by Councilmember Flores, for the Council to approve an exception to the 180-Day Wait Period (Government Code Sections 7522.56 & 21224) pertaining to the hiring of Larry Louie as extra help for critical public facility projects. Motion carried by unanimous vote.

15. APPROVED – FIRST AMENDMENT TO CITY MANAGER EMPLOYMENT AGREEMENT – 6:55 p.m.

General Services Director Shonna Halterman presented a report on a request to approve the First Amendment to City Manager Employment Agreement, which sets forth the terms and conditions of the appointment of Luke Serpa as City Manager through June 30, 2020. The City Council appointed Luke Serpa as the City Manager effective July 1, 2017, and approved an employment agreement which sets forth the terms and conditions of that appointment along with a three year contract. The Council originally set the City Manager's annual salary at Step 1 of the City Manager's salary schedule that was in effect on July 1, 2017. The Council desires to place the City Manager on Step 2 of the salary schedule effective as of January 1, 2019. After evaluating the City Manager's performance, the Council desires to provide Serpa with the equivalent of a first employee step increase, which amounts to a 5% adjustment in salary. Serpa's annual salary shall be \$216,636 effective as of January 1, 2019. Serpa shall also be entitled to receive cost of living adjustments made applicable to all executive management employees, including

those that become effective fiscal years 2019/2020. There being no public comment, Mayor Whalen closed the public portion. Discussion by the Council.

Motion by Councilmember Ashbeck, seconded by Councilmember Bessinger, for the Council to approve the First Amendment to City Manager Employment Agreement, which sets forth the terms and conditions of the appointment of Luke Serpa as City Manager through June 30, 2020. Motion carried by unanimous vote.

 - A. APPROVED WAIVE THE CITY'S FORMAL BIDDING REQUIREMENTS AND AUTHORIZE THE SOLE SOURCE PURCHASE OF A PIERCE VELOCITY 110' PLATFORM ALL-WHEEL-STEER QUINT FIRE TRUCK FROM GOLDEN STATE FIRE APPARATUS IN SACRAMENTO; AND
 - B. APPROVED **RES. 19-05**, A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVIS: (1) AMENDING THE PUBLIC UTILITIES DEPARTMENT BUDGET TO PROVIDE FUNDING FOR THE PURCHASE OF A FIRE TRUCK AND FIREFIGHTING EQUIPMENT; (2) APPROVING THE USE OF LEASE-PURCHASE FINANCING FOR ACQUISITION OF THE TRUCK AND EQUIPMENT; AND (3) AUTHORIZING THE CITY MANAGER TO NEGOTIATE THE TERMS OF THAT LEASE-PURCHASE FINANCING AND EXECUTE RELATED DOCUMENTS; AND
 - C. APPROVED RES. 19-06, DECLARING THE CITY'S INTENT TO REIMBURSE EXPENDITURES RELATED TO THE PURCHASE OF A FIRE TRUCK FROM TAX-EXEMPT LEASE PURCHASE FINANCING.

Battalion Chief Jim Damico presented a report on various actions associated with the acquisition of fire apparatus. Staff requests City Council approve the sole source purchase of a 2019 Pierce Velocity 110' Platform All-Wheel-Steer Quint Fire Truck as per the Clovis Fire Department's apparatus specifications. This purchase would replace the Quint ladder truck purchased in 1998 by the Clovis Fire Department's fire apparatus fleet, placing the existing Quint ladder truck in "reserve" status for a minimum of 10 years, and eliminating the oldest quint ladder truck in the fleet. In order to allocate the cost of this Quint ladder truck over its useful life, lease purchase financing is recommended. The lease purchase structure is also appropriate for this purchase due to the attractive interest rates available for tax-exempt financings. To attain the pre-payment discount pricing for the truck, the City will purchase the fire truck and related equipment. Lease financing will then be obtained. Per IRS regulations, in order to pay the invoices prior to lease funding availability, the Council will need to approve an "Intent to Reimburse Resolution" to keep the exempt status of the financing. There being no public comment, Mayor Whalen closed the public portion. Discussion by the Council.

Motion by Councilmember Ashbeck, seconded by Councilmember Flores, for the Council to waive the city's formal bidding requirements and authorize the sole source purchase of a Pierce Velocity 110' platform all-wheel-steer Quint fire truck from Golden State fire apparatus in Sacramento. Motion carried by unanimous vote.

Motion by Councilmember Ashbeck, seconded by Councilmember Flores, for the Council to approve a resolution of the City Council of the City of Clovis: (1) amending the Public Utilities department budget to provide funding for the purchase of a fire truck and firefighting equipment; (2) approving the use of lease-purchase financing for acquisition of the truck and equipment; and (3) authorizing the city manager to negotiate the terms of that lease-purchase financing and execute related documents. Motion carried by unanimous vote.

Motion by Councilmember Ashbeck, seconded by Councilmember Bessinger, for the Council to approve a resolution declaring the city's intent to reimburse expenditures related to the purchase of a fire truck from tax-exempt lease purchase financing. Motion carried by unanimous vote.

17. RECEIVED AND FILED - FALL 2018 CLOVIS TRAIL COUNT REPORT 7:22 p.m.

Assistant Engineer Colleen Vidoroff presented a report on the Fall 2018 Trail Count. The City of Clovis Trail Count provides an answer to the important question of how many people use the Clovis trails. The traffic on the trails has a wide range of volumes, daily use, and modal splits. The count results show the trails are highly used and valued by the City of Clovis residents and the importance of connectivity, amenities, destinations, and location to encourage trail use. The results show the City of Clovis Trails are used by both bicyclists and pedestrians for commuting and recreation. There is data to confidently indicate that the trails of Clovis were visited by over 1.7 million trail users each year for the past two years. There being no public comment, Mayor Whalen closed the public portion. Discussion by the Council. It was the consensus of City Council to receive and file the report.

EXECUTIVE SUMMARY

The project involves demolition, relocation and adjustment of various existing improvements, and reconstruction of the west side of Clovis Avenue, between 7th Street and Bullard Avenue, inclusive of asphalt concrete, concrete sidewalks, walks, drive approach, curbs, gutters, curb ramp, and pads, striping, signage, decorative posts and street lights, landscaping, and irrigation systems, and all other details as described in the Contract Documents.

BACKGROUND

The following is a summary of the bid results of January 8, 2019:

Don Berry Construction, Inc. Machado & Sons Construction, Inc. JT2, Inc. dba Todd Companies	\$ 196,979.50 \$ 222,054.00 \$ 249,346.00
ENGINEER'S ESTIMATE	\$ 174.933.00

All bids were examined and the bidders' submittals were found to be in order. Staff has validated the lowest responsive bidder contractor's license status.

FISCAL IMPACT

This project was budgeted in the Community Investment Program. The project is supported by redevelopment funds, Parking and Business Improvement Area funds, and State Route 168 relinquishment funds.

REASON FOR RECOMMENDATION

Don Berry Construction, Inc. is the lowest responsible bidder. There are sufficient funds available for the anticipated costs of this project.

ACTIONS FOLLOWING APPROVAL

- 1. The contract will be prepared and executed, subject to the Contractor providing performance security that is satisfactory to the City.
- 2. Construction will begin approximately two (2) weeks after contract execution and be completed in twenty-five (25) working days thereafter.



EXECUTIVE SUMMARY

The project consists of removal and replacement of existing deteriorated 6" and 8" vitrified clay sewer mains with 8" PVC sewer main, reconnection of laterals, trench resurfacing, manhole repair, and striping and pavement markings. Also included is modification of the existing manhole at Alamos and Burgan Avenues to improve flow characteristics and serviceability.

BACKGROUND

The following is a summary of the bid results of January 8, 2019:

All bids were examined and found to be in order with the exception of a minor arithmetic error in the third lowest bid, which did not change the order of the bidders. Staff contacted the California State Contractor's Board and was informed that Haydon Construction is properly licensed and is in good standing with no record of complaints filed against them.



RECOMMENDATION

- 1. For the City Council to pre-authorize the City Manager to award the subject project to the lowest responsible bidder and;
- 2. For the City Council to authorize the City Manager to execute the contract on behalf of the City.

EXECUTIVE SUMMARY

Staff is recommending that City Council pre-authorize the City Manager to award and execute the contract to the lowest responsible bidder so that the contractor can order the retractable bollards and construction can begin as soon as possible. This will minimize the impact to Old Town Clovis Farmer's Markets and other events during the summer time. Staff expects that the bollards will be delivered approximately 12 weeks after the order is placed.

The construction involves the installation of 47 vehicle-rated retractable bollards along Pollasky Avenue from Third Street to Fifth Street. The work involves excavation, saw cutting. trenching, backfilling, compaction, installing and leveling the bollard assembly, installing gravel and concrete foundations, and surface improvements. Future phases plan for installation of additional vehicle-rated bollards to provide protection for larger Downtown Special Events when sufficient funding is available.

This action by City Council will allow staff to move forward with the project in the most effective manner.

BACKGROUND

The project specifications have been made available to prospective bidders. The bid opening is scheduled for January 29, 2019. The construction cost is estimated at \$288,000. The apparent low bidder will be determined following the bid opening process, and the project award will take place after staff has validated the bidder's license status through the California State Contractor's Board.

Staff has evaluated the project site and all design aspects within the scope of this project for compliance with the Americans with Disabilities Act (ADA) accessibility standards as of January 22, 2019. The project will be ADA compliant upon completion.

FISCAL IMPACT

This project is budgeted in the 2018-2019 Community Investment Program. The construction cost has been estimated as noted above and funding is available and allocated at this amount. Staff will evaluate the lowest responsible bids in comparison with the estimated construction costs and will execute the contracts only if the lowest bid is financially responsive to the allocated funding.

REASON FOR RECOMMENDATION

Staff is requesting that the City Council pre-authorize the City Manager to award and execute the contract for the project to the lowest responsible bidder that meets the contract requirements. Staff is requesting this expedited process to minimize the impact to Old Town Clovis Farmer's Markets and other events during the summer time.

ACTIONS FOLLOWING APPROVAL

- 1. Staff expects to open bids and determine the lowest responsible bidder for the project, and Council will receive a report of the bid awards.
- 2. The contract will be prepared and executed, subject to the Contractor providing performance security that is satisfactory to the City.
- 3. Construction will begin after contractor receipt of the retractable bollards and be completed in twenty-five (25) working days thereafter.


