

CITY OF CLOVIS LEGAL DECLARATIONS

FOR BUILDING PERMITS



FOR CONTRACTORS

By signing this form, I hereby affirm that I am licensed under provisions of Chapter 9 (commencing with section 7000) of Division 3 of the Business and Professions Code, and my License is in full force and effect.

FOR OWNER-BUILDERS

By signing this form, I hereby affirm that I am exempt from the Contractor's License Law for one or more of the following reasons (Sec. 7031.5, Business and Professions Code: Any city or county which requires a permit to construct, alter, improve, demolish, or repair any structure, prior to its issuance, also requires the applicant for such permit to file a signed statement that he is licensed pursuant to the provisions of the Contractor's License Law (Chapter 9 (commencing with Section 7000) of Division 3 of the Business and Professions Code) or that he is exempt there from and the basis for the alleged exemption. Any violation of Section 7031.5 by any applicant for a permit subjects the applicant to a civil penalty of not more than five hundred dollars (\$500).):

- 1. I, as owner of the property, or my employees with wages as their sole compensation, will do the work and the structure is not intended or offered for sale (Sec 7044, Business and Professions Code: The Contractor's License Law does not apply to an owner of property who builds or improves thereon, and does such work himself or through his own employees, provided that such improvements are not intended or offered for sale. If however, the building or improvement is sold within one year of completion, the owner-builder will have the burden of proving that he did not build or improve for the purpose of sale.)
- 2. I, as owner of the property, am exclusively contracting with licensed contractors to construct the project (Sec. 7044, Business and Professions Code: The Contractor's License Law does not apply to an owner of property who builds or improves thereon, and who contracts for such projects with a contractor(s) licensed pursuant to the Contractor's License Law.).
- 3. I am otherwise exempt under the Business and Professions Code and have provided documentation to the City of Clovis detailing my specific exemption. By signing this form, I acknowledge that, except for my personal residence in which I must have resided for at least one year prior to completion of the improvements covered by this permit, I cannot legally sell a structure that I have built as an owner-builder if it has not been constructed in its entirety by licensed contractors. I understand that a copy of the applicable law, Section 7044 of the Business and Professions Code, is available upon request when this application is submitted or at the following Web site: https://leginfo.legislature.ca.gov/faces/codes.xhtml.

By signing this form, I acknowledge that, except for my personal residence in which I must have resided for at least one year prior to the completion of the improvements covered by this permit, I cannot legally sell a structure that I have built as owner-builder if it has not been constructed in its entirety by licensed contractors. WORKERS COMPENSATION

WARNING: Failure to secure workers' compensation coverage is unlawful, and shall subject an employer to criminal penalties and civil fines up to one hundred thousand dollars (\$100,000), in addition to the cost of compensation, damages as provided for in Section 3706 of the Labor Code, interest, and attorney's fees.

By signing this form, I hereby affirm under penalty of perjury one of the following declarations:

I have and will maintain a certificate of consent to self-insure for workers' compensation, issued by the Director of Industrial Relations as provided for by Section 3700 of the Labor Code, for the performance of the work for which this permit is issued.

I have and will maintain workers' compensation insurance, as required by Section 3700 of the Labor Code, for the performance of the work for which this permit is issued.

I certify that, in the performance of the work for which this permit is issued, I shall not employ any person in any manner so as to become subject to the workers' compensation laws of California, and agree that, if I should become subject to the workers' compensation provisions of Section 3700 of the Labor Code, I shall forthwith comply with those provisions.

GENERAL LEGAL DECLARATION

The permit associated with this form becomes null and void if work or construction authorized is not started within 180 days, or if construction or work is suspended or abandoned for a period of 180 days (failure to pass a required inspection every 180 days will constitute abandonment of work) any time after work is commenced. Failure to request progress inspections and pass in any 180 day period is evidence that work has been abandoned.

I have read and understand the business license requirements of the City and agree to abide by them.

I hereby agree to save, indemnify and hold harmless the city of Clovis or its officers, employees and agents against all liabilities, judgments, costs and expenses which may in any way accrue against the City of Clovis in consequences of this permit, and will in all things strictly comply with the conditions of the permit, regulations and ordinances of the City of Clovis and the laws of the State of California.

Approved plans and specifications shall not be changed, modified or otherwise altered without authorization by the Building Division, and all work shall be done in accordance with applicable laws and ordinances regulating building construction.

I certify that I have read this form and state that the above information is true and correct. I hereby authorize representatives of this City to enter upon the property of any applicable permits for inspection. I agree to comply with all City ordinances and State laws relating to building construction.
