

City of Clovis Water Division

Residential Rebates Eligibility Requirements

(Effective July 1, 2022 thru December 31, 2022)

- ❖ Applicants must be a City of Clovis or Tarpey Village residential customer with a current water account in good standing. Rebates are distributed on a first-come first-served basis until funds are distributed.
- ❖ Applicants must live in a single-family residence where the City of Clovis water meter serves one dwelling unit. Products purchased must be used at this residence.
- ❖ Due to budget restraints, multi-family units (i.e. Apartment Complexes, Triplex/Duplex Housing Units, etc.) are limited to the same requirements as Single-Family Residences which are as follows:

Rebate Limitations:

1 Washing Machine Rebate per Water Service Meter Account
Up to 3 Toilet Rebates per Water Service Meter Account
- ❖ Applications must include a copy of the proof of purchase in the form of a sales receipt or purchase invoice that specifies the product(s) and date.
- ❖ Rebates are for new products only. Pre-existing products **are not** eligible.
- ❖ Prior to approval, an **on-site inspection is required before changing out old toilets** by the City of Clovis Water Division. Please call (559) 324-2606 to schedule an appointment.
- ❖ The total rebate per item will not exceed the receipt amount.
- ❖ Rebate Program is effective from **July 1, 2022 thru December 31, 2022**. The application must be received within 6 months of purchase.
- ❖ Apply for each rebate separately or at the same time.

Sunnyside Clovis, CA 93611</p> <p style="text-align: center;"><i>(Please allow 4 weeks for processing)</i></p> </div>	<p>Apply for a \$75 rebate when you replace your current 5 gallons or more water-wasting toilet (i.e. Toilets made before 1990) with a new ultra low-flow toilet.</p> <p>Note: 3.5 gallons low-flow toilets do not qualify for the rebate (i.e. Toilets made during the early 1990s).</p> <p>Limit: Up to 3 toilets per household.</p> <p>To apply for the Ultra Low-Flow Toilet Rebate, please call (559) 324-2606 to schedule the first of two (2) inspections of toilet(s). The first inspection is to see if the existing toilet(s) qualify for the rebate. If the toilet(s) qualify for the rebate, the homeowner is then required to purchase and have installed the new toilet(s) and then call (559) 324-2606 for a second inspection. During the second inspection, please be sure to have a copy of your sales receipt showing your toilet purchase(s) available for the inspector.</p> <p style="text-align: center;"><i>(Please allow 4 weeks for processing)</i></p>

- ❖ Application must include a copy of the proof of purchase in the form of a sales receipt or purchase invoice that specifies the product(s) and date. Rebate value up to \$75.00 per toilet, not to exceed the actual cost of the toilet.
