





Incidents decreased from 2019 by 2%. A large percentage of that is from the COVID-19 pandemic. Beat 5 is the highest beat for incidents. This beat includes the Clovis Police Headquarters, which constitutes a high percentage of incidents.

INCIDENT COMPARISON

Public initiated incidents are down from 2019**.

911 calls increased by 20%.

Officer initiated calls increased by 4% in 2020.**

Overall there was 2% decrease in all calls for service from 2019 compared to 2020.




INCIDENTS- TIME OF DAY

Public initiated incidents: the highest day for calls is Friday. The highest hour is 1500-1600. Monday has the highest peak time of 1500-1600 hours. Overall 1000-1500 hours is peak time for public driven incidents.


Officer initiated: the highest day for calls is Tuesday. The highest hour for calls is 2200-2300 Tuesday between 1500-1600 is peak time for officer initiated calls. ***These calls include CSO self-initiated incidents.

INCIDENT PRIORITY

A slight decrease in Priority 1 (emergency) calls from 2019 to 2020. A decrease in priority 2's and 4's. An increase of priority 3's from 2019 to 2020. * Increase of telephonic priority due to COVID-19 pandemic.

Public initiated priority calls:

Priority 1's: Highest day is FRIDAY and highest time is 1600-1700 hours. The overall highest day and time is **TUESDAY AT 1800-1900 hours.**

Priority 2's: Highest day is FRIDAY and highest time 1700-1800 hours. The overall highest day and time is **FRIDAY AT 2000-2100 hours.**

Priority 3's: Highest day is SATURDAY and highest time 2200-2300 hours. The overall highest day and time is **SATURDAY AT 2300-0000 HOURS.**




TRAFFIC COLLISIONS

In 2020, Clovis had 679 collision reports. This is a 25% decrease from 2019. 311 people were injured in collisions in 2020. This is a decrease of 54% compared to 2019.

Six fatalities were reported in 2020 compared to zero in 2019.



Friday is the highest day of collision reports, with Monday being the next highest day. The highest time of day is between 1600 and 1700 hours. The highest day and time is Monday between 1600-1700 hours.

TRAFFIC : CITATIONS

Clovis Police issued 5,532 traffic citations in 2020. This is an increase of 7% from 2019 where 5,144 traffic citations were issued.

The top two violations are unsafe speed and use of handheld devices while driving. Failure to prove insurance is the third highest cited violation.


The top 10 intersections for traffic citations are mostly on Shaw and Herndon.

CRIMES AGAINST PERSON


An increase in murder and weapon law violations. A decrease of in all other crimes.



QUALITY OF LIFE CRIMES

The following categories increased: Drug Equipment Violations, Drug/Narcotic Violations, False Pretenses, Prostitution, Trespass of Property and Vandalism.

The following categories decreased: Counterfeiting, Credit Card Fraud, Driving Under the Influence, and Impersonation.




PROPERTY CRIMES

Comparison of Property Crimes:

A slight decrease in Residential and Commercial Burglary compared to 2019. A decrease of 36% in shoplifting (due to COVID-19).

An increase of 50% in Theft from Motor Vehicle and an increase of 19% in Theft of a Motor Vehicle.


In 2020, Clovis Police seized 28% more guns for evidence than in 2019. We also seized 43% more guns for felony cases than in 2019. Twenty-nine more handguns were seized, which is a 53% increase compared to 2019.

DOMESTIC VIOLENCE


Domestic violence cases have decreased slightly from 2019 to 2020.

Clovis Police made 11% less arrests in 2020 than 2019. A majority of those were misdemeanor arrests. Felony arrests slightly increased in 2020. The highest month of arrests was in August.



PROBATION –ADULT COMPLIANCE TEAM

Clovis has provided two officers for the Adult Compliance Team (ACT) in Fresno County. ACT had 194 **arrests and recovered 28 firearms in 2020. On average there are 2,294 subjects on supervision under AB109 and of that 692 subjects are on AB109 warrant status and 214 in MS warrant status in Fresno County.

Clovis has on average:

47 subjects on AB109

291 subjects on Felony Probation

149 subjects on Misdemeanor Probation

36 on Pre-Trial Supervision

191 on Warrant Status (including all old, deported and current status)

** Numbers will not be compared due to COVID-19 restrictions on the team.
