NOTICE IS HEREBY GIVEN that on **Monday, November 13, 2023, at 6:00 p.m.**, a public hearing will be conducted in the Council Chamber of the Clovis Civic Center, 1033 Fifth Street, Clovis, CA 93612. The Clovis City Council will consider the following item:

1. Consider items associated with the Draft City of Clovis Active Transportation Plan Update, including the goals and policies, existing conditions, proposed networks, implementation actions, and the Plan’s CEQA document. City of Clovis, applicant.
 - a. Consider Approval - Res. 23-____, A request to approve an environmental finding of a Negative Declaration for the Draft City of Clovis Active Transportation Plan Update.
 - b. Consider Approval - Res. 23-____, A request to approve the Draft City of Clovis Active Transportation Plan Update.

The Planning Commission considered the Project described above at its October 26, 2023, public meeting, at which time it adopted resolutions recommending approval of Items 1a. and 1b.
