

NOTICE OF PUBLIC HEARING AND PUBLIC COMMENT PERIOD FOR A SUBSTANTIAL AMENDMENT TO THE 2019-2020 ACTION PLAN AND THE 2016-2020 CONSOLIDATED PLAN FOR COMMUNITY DEVELOPMENT BLOCK GRANT – CORONAVIRUS (CDBG-CV) FUNDING

NOTICE IS HEREBY GIVEN, that the Clovis City Council will hold a public hearing on **December 2, 2024 at 6:00** p.m. in the Clovis Council Chambers located at 1033 Fifth Street, Clovis, California to review and discuss approval of a Substantial Amendment to the 2019-2020 Community Development Block Grant (CDBG) Action Plan and 2016-2020 Consolidated Plan for the use of Community Development Block Grant - Coronavirus (CDBG-CV) funds, as described below. The facility is readily accessible to individuals with mobility impairments. The hearing is an opportunity to consider any comments or views of citizens, groups, public agencies, and other interested parties regarding the Substantial Amendment, as required by the U.S. Department of Housing and Urban Development (HUD). The federal Coronavirus Aid, Relief and Economic Security Act (CARES Act) provides CDBG-CV funding for grants to prevent, prepare for, and respond to the spread of the coronavirus.

CDBG-CV funds are proposed to be utilized as follows:

- Utilities Payment Assistance Program (reduction): (\$130,876)
- CDBG-CV Administration (reduction): (\$25,000)
- Water Tower 1 Plaza at Old Town Trail Improvements: \$155,876

Public Comment:

By this notice, the City of Clovis commences a 30-day public review and comment period. The City of Clovis invites parties that have an interest in, or may be impacted by, the activities identified above, to submit a written comment in-person, via telephone, via mail or e-mail (see contact information below) and/or attend the Public Hearing to provide their views and comments.
